Nominated companies will be notified with a copy of the completed nomination form along with an invitation to an Orientation Meeting.

Application Process:

This nomination begins a process whereby, with guidance and clear guidelines, the nominated company will be asked to prepare an application for submission. By means of an evaluation, three finalists from each of three business size groups will be selected. A Judging Panel of business and community leaders will select one Crystal Award recipient from each of the groups.
